I was fortunate to have been at the Jericho Selectboard meeting on September 15, 2016 when Honorary Fire Chief Mr. Randy Clark Sr. was on the agenda to speak about the Rivers property. For a number of years, this land and its future have been discussed. Many travelers on Browns Trace relish the expansive views that help create the scenic gateway to Jericho Center. Mr. Clark began his PowerPoint presentation by giving a quick summary of how the Underhill Jericho Fire Department (UJFD) received this property from Alice Rivers. He said that it



time considering them. But then, he quietly announced with a tear in his eye that their final decision had been made and it was to transfer the Rivers property to the Town of Jericho. Now it was our turn to be shocked... and delighted. Similarly he asked that the transaction take place by October 1st, a very short time. Everyone in the room was speechless and very appreciative. We clapped as Mr. Clark shook hands with the Selectboard members and as the other Chiefs came forward. Now, the Town of Jericho and its residents have the opportunity to consider the

was a shock as the UJFD had only asked for three acres and the timing was sudden as she wanted the property transferred by January 1st. It was already Christmas time. Mr. Clark went on to explain that offers have been made on certain sections of the Rivers property and the UJFD spent substantial ways that the Rivers property can continue its scenic role along with other benefits. The Jericho Underhill Land Trust will be advocating for the conservation of this special land.

# HOW TO USE THE FEDERAL TAX DEDUCTION

In 2015 Congress enacted one of the most powerful conservation measures in decades: the enhanced federal tax incentive for conservation easement donations.

The permanent conservation easement tax incentive is a powerful tool that helps Americans conserve their land voluntarily. For land trusts across the country, the permanent incentive represents vastly increased opportunities to protect the special places in their widely varied communities.

If you own land with important natural, agricultural or historic resources, donating a conservation easement can be a prudent way to both save the land you love forever and to realize significant federal tax savings.

## YOU ARE INVITED!

You are invited to attend a JULT field trip ably led by our land Stewardship Chair John Koier.

We will be visiting a working landscape project on our Wolfrun Natural Area parcel that was set in motion 2 years ago. This is the first phase of a wildlife enhancement project that is a function of our Conservation Management Plan. In the Fall/Winter of 2014 a local logger completed a 3/4-acre patch-cut at the direction of our consulting forester. We will be visiting this completed patch-cut to notice changes to the vegetation and evidence of wildlife activity that we may be able to observe as compared to the surrounding untreated landscape. Prepare to see the forest landscape through the eyes of a white tailed deer, turkey or black bear. We recommend hiking shoes or similar sturdy footwear for this moderately strenuous trek over rough terrain.

### KITCHEN TABLE TALK

The decision to permanently conserve one's land can be a quiet thought, a feeling. Scanning the open meadows and forested hillsides one thinks, what will become of this? Right now, the JULT is working with several families to help make this happen.
