Our guest speaker is Lisa Gannon who has served as State Coordinator of VT New England Antiquities Research Association (NEARA) for the past nine years. Her Power Point presentation is titled <u>"Stunning Stonework: The Sacred</u> Landscape of West Bolton, Vermont". She writes, "There exists a myriad of enigmatic stonework in the woods surrounding West Bolton, much of it resting on land conserved by the Jericho Underhill Land Trust. The geography and the ethnographic history of the Winooski River Valley may provide important clues as to the origin of these sites. " Come join us as we explore the mystery of the ancient stone cairns.



JULT ADJUSTS MEMBERSHIP TERM

After some discussion, the JULT Board of Trustees decided to adjust the membership term so that it agrees with the calendar year. Therefore, instead of a membership term that runs from May to May, it will now run from January 1 until December 31. Members who renewed in November or December will receive membership through December 31, 2012. We believe that this change will fall more naturally into the annual cycle.
