### MAJOR FUNDING FOR THE TOMASI MEADOW!

The Jericho Underhill Land Trust is excited to report that the Vermont Housing and Conservation Board (VHCB) has awarded \$155,000 towards the Town of Underhill's conservation purchase of the Tomasi Meadow. This signifigant grant funding catapaults our conservation efforts forward and greatly reduces our fundraising need. The total cost of a conservation purchase of the Tomasi Meadow by the Town of Underhill is \$231,000. This sum includes the land, a survey, legal work, a stewardship endowment to monitor the land in perpetuity, and all other project expenses. The remaining amount to be raised is \$76,000. There will be a vote at Underhill's Town Meeting to contribute \$20,000 towards this purchase. The Jericho Underhill Land Trust is working with the Vermont Land Trust to raise the remaining \$56,000. Local fundraising is starting now.

#### CREATING A CONSERVATION RESERVE FUND

The Jericho Conservation Commission has been gathering information about creating a Conservation Reserve Fund (CRF). Many of our neighboring towns (Richmond, Bolton, Williston) have this funding mechanism in place to help with the permanent conservation of important farm and forestland. Presently Jericho has a line item in the Town budget that is called "Open Space/Public Use". It receives funding as determined by the Selectboard and is low priority in budget discussions. A Conservation Reserve Fund

would build annually. The Jericho Conservation Commission recommends that the amount put into the fund each year would be based on adding one cent on the tax rate. This would translate to about \$10 per \$100,000 of a property's assessed value per household. Using that rate for the current fiscal year, it would generate about \$67,000. JULT fully supports establishing a Conservation Reserve Fund for the town as this would greatly enhance the land trust's ability to protect important land when funding is needed.
