### WHO WE ARE

The Jericho Underhill Land Trust (JULT) is an all volunteer, non-profit organization established in 1989 to permanently protect our Towns' working landscape, scenic vistas and important wildlife habitats.

### WHAT WE DO

JULT accomplishes our conservation mission by working hand-in-hand with willing landowners, local government and interested citizens in several ways:

- ▲ through the donation or purchase of conservation easements (legal agreements that permanently limit land use to protect conservation values);
- ▲ by conserving property directly through donation or purchase;
- ▲ by providing consultation on local planning issues, and to private citizens regarding the possible tax benefits of land conservation.





### WHAT WE'VE ACCOMPLISHED

JULT has provided the leadership to make major conservation projects a reality:

▲ **OLD MILL PARK** (adjacent to the Old Red Mill in Jericho Corners): In 1991, JULT was instrumental in the creation of this 12-acre refuge for picnicking, hiking, and cross-country skiing along the Browns River. The park is now owned and managed by the Winooski Valley Park District.

▲ **MILLS RIVERSIDE PARK** (on VT Rt. 15 in Underhill Flats): JULT raised the funds to acquire this spectacular 216-acre parcel in 1999. We transferred ownership to the Jericho Underhill Park District in 2000 and donated a conservation easement to the Vermont Land Trust, forever protecting open meadowlands and forested hillside terrain that provides wildlife habitat, diverse recreational opportunities, and exquisite views of Mt. Mansfield.



▲ **WOLFRUN NATURAL AREA** (access off of Stage Rd. in Bolton): In 2003, JULT purchased this 279-acre property

to protect key wildlife habitat and travel corridors. This rugged land encompasses remote cliffs and ledges, a magnificent forest and a pristine wetland complex.

### ▲ CASEY'S HILL (Pleasant Valley Rd., Underhill):

In 2005, a traditional sledding hill and spectacular scenic vista were saved from development through the efforts of JULT, the Town of Underhill and many conservation organizations and concerned citizens.



### ▲ KIKAS VALLEY FARM

(on Tyler Place, just off Skunk Hollow Rd., Jericho): In 2005, JULT received 280 acres of farm and forest with trails and donated a conservation easement to protect the land and ensure its continued agricultural use.

▲ Other successes include working with landowners to permanently protect their land through a conservation easement donation. In 2000, 166 acres of critical wildlife habitat for black bear, moose and bobcat were conserved in Jericho. In 2006, over 279 acres of scenic meadow and forest were preserved in Underhill.

Currently, we are exploring exciting land conservation opportunities within Underhill and Jericho and look forward to creating new partnerships. We are also actively involved in the *Chittenden County Uplands Conservation Project* which is a collaboration of local and statewide land trusts with a focus on eastern Chittenden County, Vermont.
